Survey Methodology

- Conducted March 13 December 2, 2024, among a probability sample of 20,642 adults who are part of the Ipsos KnowledgePanel plus 1,618 state level opt-in oversamples, for a total sample of 22,260 adults.
- The margin of error for the full sample is +/- 0.84 percentage points and has a design effect of 1.6.
- The survey was made possible through the generous support of the Arcus Foundation, the E. Rhodes and Leona B. Carpenter Foundation, the Gill Foundation, and the Unitarian Universalist Veatch Program at Shelter Rock.


A Look at LGBTQ Americans

- One in ten Americans (10%) identify as part of the LGBTQ community;
 this includes 3% who identify as gay or lesbian, 4% who identify as bisexual, and 2% who identify as "something else."
- Around one in four Gen Z adults identify as LGBTQ (24%), followed by 13% of millennials, 7% of Gen Xers, 4% of baby boomers, and 2% of members of the Silent Generation.



Percent who identify as LGBTQ:





Percent who favor nondiscrimination laws for LGBTQ people:









Percent who oppose allowing a small business owner to refuse to provide products or services to gay or lesbian people, if doing so violates their religious beliefs:









Percent who support allowing same-sex marriage:









Percent who oppose laws that would prevent parents from allowing their child to receive medical care for a gender transition:







Percent who oppose laws that require driver's licenses or government IDs to display a person's sex at birth rather than their gender identity:


